COURSE CANCELLATION EXPENSES

For the summer course

The Insured will be compensated for the travel cancellation expenses if, the student, at the end of the school year, has failed three or more subjects and due to it, the trip doesn't take place. This coverage will take effect provided that, during the school year, the student has not failed two or more subjects during three consecutive evaluations.

For the school year

The Insured will be compensated for the travel cancellation expenses if, the student, have to take the exams in September in, at least three subjects of the course, except: P.E. Religion, Ethics, Music, arts and crafts, or any other subject considered complementary of the basic subjects of the course. This coverage will take effect provided that, during the school year, the student has not failed two or more subjects during three consecutive evaluations
